

Original owner of this land was Shri Vadilal Dolatchand. Thereafter Shri Vadilal Dolatchand sold this land by Regd. Sale deed to Shri Remanbhai Daudbhai on Dt. 27/06/1944 for Rs. 900/. (Entry No. 509, Dt. 25/10/1945). Thereafter Remabhai Daudbhai executed Regd. Mortgage deed in favour of Hargovan Mulshankar and Ramnarayan Mulshankar on Dt. 21/05/1947 for Rs. 500/-. (Entry No. 540, Dt. 14/05/1949). Thereafter Ramanbhai Daudbhai paid Rs. 500/- to Shri Hargovan Mulshankar and Ramnarayan Mulshankar, therefore Shri Hargovan Mulshankar and Ramnarayan Mulshankar executed Regd. Re-Convenience deed in favour of Shri Remanbhai Daudbhai on Dt. 09/05/1956. (Entry No. 604, Dt. 22/10/1956).
